HOW THE CAMP CARD SALE WORKS

The Camp Card fundraiser is a **risk-free** fundraiser designed to assist Scouts in fundraising for their summer activities, while reducing out of pocket costs for their families.

How it Works:

- Sell cards for **\$10.00** and earn **50%** commission!
- No prizes or prize orders.
- Card contains discounts for: Silverwood, Rosauers, Dicks Sporting Goods, Super 1, and much more! (see full list in the camp card flyer at www.nwscouts.org/campcards)
- **March 18-20:** Distribution of Cards
- **March 20:** Sale begins
- **April 6-10:** No Penalty, Mid-Sale Turn-in days units can return any undamaged, unsold cards. If your unit is struggling to sell inventory please bring in your unsold cards to the Spokane Office or a spot determined by your District Executive so we can redistribute them.
- **May 18:** Sale ends.
- **May 22:** Camp Card Final Payment, Unsold card turn in.
- Payments and Cards turned in after **May 22nd** will receive **35%** commission.

NOTE: All fundraising money stays in the Unit (Pack/Troop/Crew) to spend on sending Scouts to camp. The Council does not decide how the money is spent.

STOREFRONTS

Many Scouts sell camp cards in front of our community businesses in addition to door-to-door sales. It is the Unit/Scout's responsibility to check with store management to arrange sales. We advise that you speak to your local businesses, venues, churches, and other supporting organizations in your community about the possibility of supporting Scout fundraisers.

Units should NOT schedule storefronts in front of Rosauers and Super1.
